1. JURISDICTION:

This event is a RallySprint, promoted by the **South Auckland Car Club** and will take place on **Sunday 2nd August 2020** in the **Maramarua Forest**, **HQ Block**.

This Rallysprint is Round 4 of the ABC Pipefitters, Northern Rallysprint Series.

The RallySprint will be held under these Supplementary Regulations, the current Motorsport NZ National Sporting Code and its Appendices and Schedules particularly Appendix Three, Schedule R S being the Standing Regulations for all RallySprints and Appendix Two, Schedule A – Driver and Vehicle Safety Requirements.

3. THE EVENT

- 3.1 Venue: Maramarua Forest HQ Block.
- 3.2 Length: Comprises of approx 8 km of forestry special stage and 6 km of touring.
- 3.3 There will be a system of elimination as per the NRSS Rules, with final judgement at the sole discretion of the Clubs Organising Committee.

4. ENTRIES

- **4.1 Opening and Closing:** These open with the publication of these regulations and close at 5pm on Monday 27th July 2020
- **4.2 Entry Acceptance:** Entries shall be made on the correct form and to be deemed valid must be complete in all details and accompanied by the appropriate fees. Acceptance will be at the organising committee discretion. Organisers reserve the right to refuse any entry in accordance with the prescribed provisions of the National Sporting Code.

Priority Entry for previously registered 'ABC Series' competitors will be given.

4.3 Fees:

- 4.4 Dual Drivers will be accepted, but must adhere to the CoC directions.
- The organisers reserve the right to abandon the event if less than 25 entries are received at 4.5 the closing date. Maximum number of starters 70.

4.6 **Competitor Requirements:**

- Knowledge and Understandings: In signing the entry forms competitors (Entrant and Drivers) are deemed to fully understand the Motorsport NZ National Sporting Code and its relevant Appendices and Schedules.
- Licence Requirements: the driver must have as a minimum an 'M Grade' licence. (2)

5. **ELIGIBLE VEHICLES**

- 5.1 Compliance: All vehicles shall comply with Appendix Two Schedule A and Appendix Three Schedules R of the current Motorsport Manual unless stated otherwise in these supplementary regulations.
- 5.2 All Vehicles will require a current Registration and WoF.
- 5.3 Classes: Vehicles will be divided into the following classes: (A) 0 - 1300, (B) 1301 - 1600, (C) 1601 – 2000, (D) 2000 – Over, (E) 4WD, (G) Historic 4WD (H) Historic 2WD

6. **DOCUMENTATION AND SCRUTINEERING AUDIT**

Competitors must present themselves at documentation for the checking of licences and documents, issuing of competition numbers and applicable advertising material prior to presenting the car for audit scrutinering.

Cars will not be cleared to compete until all of these numbers and advertising requirements are firmly affixed in the appropriate places on the vehicle.

- The venue for this will be at the event HQ at the Forestry HQ, Schumaker Road, Maramarua, From 8.00pm to 9.00am.
- 6.2 Drivers briefing will follow documentation at approx 9.15 am with recce run straight after, (Please ensure you are ready to race when attending drivers briefing) All competitors must Travel the course under the supervision of the Clerk of Course.
- 7. **TIMING & RESULTS:** Will be electronic start lights and beam finish, you will be penalized for jumping the start, penalty of 20 seconds, as deemed by the Start Line Official. Provisional results will be posted at the HQ (club trailer), and final results will be posted at the after function at the Red Fox Tavern, Maramarua.

8. **GENERAL:**

Food and drinks will be available at the venue

Please collect all your rubbish and leave the area as we found it.

Any competitor withdrawing from the event must notify the event secretary or face exclusion from the results.

All drivers will be liable for damage they may cause.

You require a co driver/passenger, for this event, they will need to sign an indemnity form and have a stamp on their hand, this will be checked at the start, no stamp no start, the form will be at HQ. Also make sure your passenger is familiar with the safety items in your car and know how to use them.

Please make sure you read and understand the safety and emergency procedures, and use them if need be. (App R, Art 14)

A trail vehicle will follow the last car of each run if necessary, to check and clear the road. Any cars off the road and causing no danger to others will stay there until the end of the session, and any will be towed if possible, at the Clerk of Course's discretion.
